- Tuition Payment Plan Options (school fees included)
- These rates are valid through June 1, 2024. Students who enroll after June 1, 2024, are subject to alternate payment plans. Families will complete a payment plan through Rancho Central tuition management system. This process will be done through the Online Enrollment Packet. Both credit cards and EFTs (“cash”) are accepted for tuition payments through this system. Please note if using a credit card, a convenience fee will apply.
- Annual Payments are due by June 1, 2024.
- Bi-Annual Payments are due by June 1, 2024 & December 1, 2024.
- The monthly payment plan listed above is for payments beginning June 1, 2024 and ending May 1, 2025.

Co-Curricular Fees

- Participation in co-curricular activities may have additional fees to cover supplies, uniforms, coaching & directing stipends, chaperones, etc. Costs vary but some programs offer fundraising programs or payment plans to offset fees.
- Examples of these fees include (but are not limited to): Overnight Trips, Yearbooks, Athletics, Performing Arts, Class Pictures, Academic Clubs & Programs.

Withdrawal

- The withdrawal policy includes parent withdrawal requests, student absences, and/or expulsions.
- February 01, 2024 - Deadline for families to opt-out of continuous enrollment. The enrollment fee will not be charged. No tuition obligation for 2024-2025.
- For withdrawals received during the following periods:
- Feb 2 - April 30, 2024 - No Tuition Responsibility (Enrollment Fee is non-refundable)
- May 1 - July 01, 2024 - Responsible for 25% of the annual tuition obligation. (Enrollment Fee is non-refundable)
- July 2 - Aug 19, 2024 - Responsible for 50% of the annual tuition obligation. (Enrollment Fee is non-refundable)
- Aug 20, 2024 & thereafter - Responsible for 100% of the annual tuition obligation. No refunds or credits will be issued. (Enrollment Fee is non-refundable)

Past Due Accounts

Families with past due accounts may not be able to participate in co-curricular activities such as extended care, arts, athletics, field trips, leadership, etc. until the account has been brought current.
